# **ASSESSMENT**

The qualification is divided into two units, which are assessed in the following ways:

Unit EMC2 Assessing environmental aspects and associated	Practical Assessment Learners will be required to assess environmental aspects and impacts in their chosen workplace.

## NEBOSH EMC PASS STANDARD

- 1. The provisional pass mark for EMC1 is 45%
- 2. The EMC2 is marked with a pass or fail.



# CERTIFICATE

The results will be issued 10 weeks after the assessment date. Each unit is reported as 'Pass' or 'Refer'. You must pass both units to achieve the qualification.

The following qualification grades are awarded:

- Pass 45 64% in EMC 1
- Credit 65 74% in EMC 1
- Distinction 75% + in EMC 1

Unit and qualification certificates are dispatched by NEBOSH within 20 working days of the result notification date.
